White River Curling Club

- Nicole Simpson presented on behalf of the White River Curling Club. The club is interested in re-starting for this season, with assistance from volunteers and the White River Economic Development Corporation.
- The historic "rental" agreement was discussed. It was noted that there are other activities and/or users needing the space, and it would need to be a shared use arrangement.
- The Township's aim is to cover costs while also encouraging usage. Flexibility for events and activities from other clubs or users will be required.
- The current condition of the facility was reviewed, together with repairs that need to be done.
- Insurance and licensing will both be retained by the curling club.
- The Economic Development Corporation is interested and willing to help get the Curling Club up and running again.
- Communication needs to be open and continuing as matters progress.
